Dear Parents & Guardians,

The School Board is always sensitive to the impact on families when any fee increase occurs, however it is deemed necessary to increase school fees in 2025 to enable the school to continue to provide a high quality, well-resourced education for all learners in our care.

1 February 2025 School fees will increase by 9.7% for Gr1 – Gr7 and 8% for Wallies learners. Registration fees will remain N\$ 1 500 for 2026.


